Sir/ Madam,

I am desired to inform you that the provisional affiliation to run the B.A.B.Ed./B.Sc.B.Ed. 4 years integrated Course has been granted from the session 2019-20 in SKS College of Education, Kirmach, Kurukshetra (Minority institution) with an intake of 50 seats each. This is in anticipation of approval of Executive Council and subject to the fulfilment of following conditions imposed by the Inspection Committee :-

1. The college shall appoint qualified teaching faculty including Principal as per NCTE Norms through the duly constituted Selection Committee as per Kurukshetra University Rules and get the proceedings of the Selection Committee approved from the University. The teaching/non-teaching staff shall be appointed on regular basis and on the pay scales prescribed by the State Govt./Kurukshetra University.
2. The college shall abide by the norms and standards/rules and regulations as prescribed by the NCTE/Kurukshetra University from time to time.
3. You are required to upgrade the Girls common room facilities.
4. You are required that atleast one lakh should be spent on purchase of book in the library.
5. The Projector should be installed in the multipurpose hall, equipments of fifty thousand be also procured."
6. You are also required to make admissions within 10 days after the date of issue of this letter.

Kindly note that it is only provisional affiliation, in case, the college is found deficient in infrastructural facilities/teaching faculty and/or acting in violation of University directions, Rules, Regulations, Ordinance etc., the college shall be liable for penalties/disciplinary action including withdrawal of provisional affiliation.
